The purpose of Ecumenical Community Helping Others (ECHO, Inc.) is to assist people in need in our community, those who suffer the effects of long-term poverty as well as those who are experiencing an emergency financial need.

After two years of pandemic-related service adaptations, ECHO returned to a normal mode of operation by June of 2022, but with mask and vaccine mandates still in place. ECHO was able to assist 1,487 unduplicated households (5,526 individuals) in FY 2022. During the year 416 households received assistance to pay bills for housing, utilities, prescriptions, and other essential needs. In addition, 203 households received assistance through cooperative agreements with Fairfax County under the CARES Act and the Emergency Rental Assistance Program. Clients received 266,999 pounds of food plus \$48,180 in coupons for fresh produce, meat and milk; 3,386 clothing bags; and household items valued at \$130,444. 1,077 children received backpacks filled with school supplies. Included in the household items were 27 refurbished computers and 1,662 enrichment bags containing books and toys for children of client families. 521 families received holiday food, and 588 children from 241 families received holiday gifts. Beginning in March 2021 and continuing through FY2022, ECHO provided additional support to families with infants and young children, supplying full cases of disposable diapers on a monthly basis. That ECHO continued to meet client needs during the pandemic gives eloquent testimony to the maturity of the organization and its processes, the selflessness of its volunteers, and the generosity of its donors.

In May 2021, the Organization entered into an agreement with Fairfax County to provide a streamlined disbursement process to clients approved by Fairfax County to receive rental assistance under the Emergency Rental Assistance Program (ERA) funded by the U.S. Department of Treasury. Under both programs, the Organization administers and disburses funds to those clients referred by Fairfax County. As the Organization has no discretion over beneficiaries and no responsibility for determination of eligibility, these funds are treated as agency transactions and there is no impact to the Organization's revenues or expenses. The funds remaining under both of these programs as of June 30, 2022 total \$6,710 and are reported as both restricted cash and refundable advance on the audited financial statements.

Schedule I, Part I, Line 2 - MONITORING GRANTS TO ORGANIZATIONS LISTED IN PART II: Grants are in the form of in-kind donations ECHO receives from the community that are surplus to ECHO's needs or outside of ECHO's mission scope. Distributions are made to other charitable organizations which can make use of ECHO's surplus clothing, household items, donated medical equipment, and other items not usable at ECHO. ECHO does not monitor the use of these items by the organizations to which they are given. ECHO continued a cooperative program begun in FY 2021 with First Baptist Church of Springfield, in which ECHO purchased baby formula for a ministry of the church that also benefits ECHO clients. MONITORING GRANTS (CLIENT ASSISTANCE) WITHIN OUR OWN ORGANIZATION, PART III: We do not monitor our clients' use of in-kind grants of assistance. However, we do calibrate the level of assistance provided to the reasonable needs of the household involved. Moreover, we limit the frequency of such grants to ensure that our clients do not receive food clothing, housewares, or school supplies in excess of their reasonable needs. We take a different approach with financial assistance. The financial assistance we provide is for payment of essential bills, mostly for housing and utilities and also for medical prescriptions. In the case of prescriptions, we authorize a local pharmacy to fill the prescription for the client and then bill us directly. With housing and utility bills, we verify the amount owed by contacting the property manager or appropriate utility company and then make direct payment of the bill. We never provide financial assistance directly to a client. Since we are paying the bills directly, we are confident that the funds we provide are being used for the purposes we intend. Clients receiving coupons for fresh produce, meat, and milk are required to turn in a receipt to show that they have used the coupon as intended.
